**MENTIONED PERSONS & SUMMARY:**

Tanya Mantle - Witnessed Ryan Cornelison and Cory Mashburn slapping 4-6 girls in hallway. She reported activity to Steve Tillery.

Steve Tillery - VP of Patton and assisted with investigation.

Ryan Cornelison - Charged with Sex Abuse I and lodged at YCJD. Ryan touched [redacted] and [redacted] on the buttocks. Ryan also grabbed [redacted] and [redacted] breast.

Cory Mashburn - Charged with Sex Abuse I and lodged at YCJD. Ryan touched [redacted] and [redacted] on the buttocks. Ryan also touched [redacted] breast. [redacted] and [redacted] have also touched his buttocks.

[redacted] - Was touched on her buttocks by Ryan Cornelison and Cory Mashburn and [redacted]. She has never touched any of them. Ryan Cornelison grabbed her breast.

[redacted] - Was touched on her buttocks by Ryan Cornelison, Cory Mashburn and [redacted]. She also touched their butts. She's never touched [redacted].

[REDACTED] - Unable to locate him for interview. Accused of touching the buttocks of [REDACTED] and [REDACTED]

John Lynch - Juvenile Probation Officer who requested the lodging of Ryan Cornelison and Cory Mashburn.

[REDACTED] - Touched [REDACTED] buttocks once, was asked to stop and never touched her again. He was not interviewed.

[REDACTED] - Touched [REDACTED] buttocks once, was asked to stop and never touched her again. He was not interviewed.

**ACTION TAKEN:**

While conducting my initial investigation on 2/22/07, I learned some additional information that required some follow-up investigation. The first thing I learned was that several other boys may have also touched the buttocks' of female students while at school. Along with this, several girls also touched the buttocks' of certain boys in the school as well.

On 2/23/07 at 10:45 hours, I re-interviewed [REDACTED] at Patton Middle School. [REDACTED] confirmed that Cory Mashburn had slapped her on the buttocks numerous times the previous day. She believes Cory does this because he thinks it's funny. [REDACTED] added that she has also, "Swatted," Cory on the buttocks. She said the two are friends and it's an activity they have done about 10 times, or so. [REDACTED] told me that she considers her buttocks a private and intimate part of her body. She said that although she also hits Cory's buttocks when giving him, "High-Fives," it does still bother her when he touches her. She said that if it had only happened one time it would be, "Not a big deal," but he continues to do it.

[REDACTED] went on to tell me that she has seen [REDACTED] slap [REDACTED] buttocks although he has never touched hers. She told me [REDACTED] has also slapped her buttocks 1 time a couple of weeks ago. She said, "I don't know him," so she told [REDACTED] "Don't do that ever again." She said that [REDACTED] has witnessed her being slapped by [REDACTED] and she has seen [REDACTED] slap [REDACTED] before.

At 10:53 hours, I interviewed [REDACTED] at Patton Middle School. [REDACTED] told me that being slapped on her buttocks is, "No big deal." She said that Cory and Ryan have slapped her buttocks and she has also slapped theirs. "It's like a handshake we do," and it's been going on for about 2 weeks. She said this occurs daily and there has been no other contact between the group other than slapping the buttocks. She said that no other boys have touched her inappropriately at Patton.

[REDACTED] also reported that [REDACTED] has slapped her buttocks and she's seen him slap other girls as well over the past week. [REDACTED] said she has also slapped [REDACTED]. She told me, "I don't care if my friends touch my bottom." She also said she does not consider her buttocks a private part of her body. She told me that she would not want random people

touching her buttocks, but she does not find it offensive.

At 11:10 hours, I interviewed ██████████ at Patton. She said she'd witnessed others being touched and she has had her buttocks touched by ██████████ Cory Mashburn and ██████████. She said that ██████████ touched her buttocks 1 time a while back and she asked him to stop. He has never touched her since.

Cory has grabbed her buttocks, although he did not squeeze it, on two occasions. She said this took place about 2 weeks ago. ██████████ said she asked Cory to stop the first time because, "I don't like boys touching me." She went on to say that Cory has also, "Touched my boob at the last basket ball game [2/15/07]." She said he touched her with his hand. She asked him why he was touching her and he replied, "I'm doing a boob test, like who has the hardest boobs." She told him that was inappropriate. ██████████ said that she considers her buttocks and breast to be private parts of her body. ██████████ said the last time Cory touched her buttocks was at the Wild Rose dance on 2/9/07.

It should be noted that I personally worked the Wild Rose Dance on 2/9/07 and witnessed an interaction between ██████████ and Cory. I saw the two dancing together in the front row near the stage where I was standing. I actually yelled at Cory and his unknown friend because the friend was trying to push Cory's face into ██████████ breasts. I told ██████████ about this and she stated that was right around the time he grabbed her buttocks. I saw ██████████ push Cory away, but at the time, I did not know why.

██████████ also stated that ██████████ has touched her buttocks. She said he grabbed it and squeezed it, "Quite a few times." She has told him to stop but he continues touching her. She said the touching usually happens outside of school at places like the dance. She stated it has only occurred once at Patton.

██████████ has witnessed Cory and Ryan touch ██████████ and ██████████ on the buttocks in the past. She said she's seen them also grab their buttocks'. This mostly happens to ██████████ and ██████████ has heard ██████████ ask the boys to stop a couple of times. She has never seen ██████████ touch the boys back.

At 11:33 hours, I re-interviewed ██████████ at Patton. She told me that Ryan has touched her bottom 2-3 times and Cory has also touched her bottom about 10 times. She stated she does consider her buttocks a private part of her body. She also admits to touching Cory on the buttocks in the past, but has never touched Ryan. She said she usually slaps Cory's buttocks or kicks it with her foot. She has asked both boys to stop but Cory has never asked her to stop. She said she's touched Cory's buttocks, "3 times, maybe." She will touch Cory after he touches her first.

██████████ said that ██████████ has also touched her buttocks as recently as yesterday. He's done this 2-3 times before at Patton. She has never told him to stop and she has never touched him back. ██████████ witnessed the touching that took place yesterday. No one else has touched ██████████ inappropriately at school.

At 11:44 hours, I interviewed ██████████ at Patton. ██████████ stated that ██████████ slapped her buttocks at the Wild Rose dance on 2/9/07. She said she did not say anything to ██████████ but she walked away from him. ██████████ considers her buttocks a private part of her body. She has never touched anyone's buttocks and has never seen ██████████ touch anyone else.

At 11:49 hours, I interviewed ██████████ at Patton. ██████████ saw ██████████ slap ██████████ on the, "Butt." This

happened, "Last week or 2 weeks ago." She said [REDACTED] and [REDACTED] were talking and she went to leave when he slapped her buttocks. [REDACTED] heard [REDACTED] say, "Don't do that." [REDACTED] smiled and laughed at her. [REDACTED] was sort of laughing but, "I could tell she was annoyed."

[REDACTED] has also seen Cory and Ryan, "Party-boy," [REDACTED] as well. [REDACTED] said the two might have also done this to her, although she can't say for sure. This happens once in a while and she reports seeing them do it to [REDACTED] this week.

At 12:23 hours, I re-interviewed [REDACTED]. [REDACTED] said she has never touched either Cory or Ryan. She considers both her breast and buttocks to be private parts of her body. She said that [REDACTED] did touch her buttocks last year on one occasion, but she asked him to stop and he never did it again.

[REDACTED] said that [REDACTED] has also touched her buttocks this year. He spanked her bottom and she told him not to. [REDACTED] was with her and witnessed the touching when it happened. She has never touched [REDACTED] back. This occurred about 1 week ago and it only happened 1 time.

At 12:32 hours, I interviewed [REDACTED] the teacher that initially reported seeing Cory and Ryan slapping girls on the buttocks. [REDACTED] said that after C lunch, around 13:22 hours, she was walking toward the cafeteria from the gym with all the other kids. She saw Cory and Ryan run up from behind her, then slap 4-6 girls on the buttocks as they continued running. She chased after them and yelled for them to stop, which they did. She heard the girls tell the boys, "Knock it off." [REDACTED] said the 1st slap occurred about 3 feet in front of her. The only girl who she knew that got slapped was [REDACTED]. [REDACTED] did not know the names of the other girls.

At 12:48 hours, I interviewed [REDACTED] at Patton. [REDACTED] told me he was, "Fooling around," yesterday when he grabbed [REDACTED] buttocks. He also acknowledges that [REDACTED] told him to not do that. He said he's done this before, although he does not know how many times. He said [REDACTED] never says anything when he does this. He thinks she doesn't care. [REDACTED] told me, "We touch people's butts and pass it on." He said that yesterday was the 1st time anyone told him to stop. He said he has also grabbed [REDACTED] butt in the past. [REDACTED] added that he does not think it's o.k. to touch a girl's buttocks. [REDACTED] said he did not know, "Party-boy," was not o.k. He said he does this often and thinks it's funny. He claims that when he is doing it, he never actually rubs himself against a girl, only pretends.

At 13:00 hours, I interviewed [REDACTED] at Patton. [REDACTED] considers grabbing a girls buttocks inappropriate. He also considers, "Party-boy kind-of inappropriate." He said he hasn't touched any girls in a while. He has grabbed [REDACTED] and [REDACTED] buttocks, but they were, "Going out," when that happened. They also never told him to stop, although neither ever touched him back. He told me that if you are going out with a girl, it's o.k. to touch a girl if she lets you. [REDACTED] thinks a girl's buttocks is a private part of her body.

[REDACTED] added that [REDACTED] and [REDACTED] flirt with everybody. He said he's touched both of their butts and they have also touched his. Neither has told the other to stop.

I attempted to interview [REDACTED] but he was unavailable at school due to a suspension for other reasons. The address [REDACTED] has listed in McMinnville is not accurate and I learned he actually lives somewhere in Carlton.
